File Mining:

Be a sleuth! Read through case files and find the names and important contact information for relatives and other lost loved ones. If you are an exceptional note-taker, pay attention to detail, and want to help a child in need this role is perfect for you!

Become a Family Finding Volunteer

Private Investigator

"Family Finding" is a program that involves intensive searches for family members and other connections for children who are in foster care. Our Family Finding team currently uses a number of search methods, but we have more to learn! We are looking for a pro-bono private investigator to help us search for more relatives and lost loved ones for Oregon foster kids!

Qualifications:

- Experience with public record databases
- Refined research skills
- Knowledge of exceptional "people finder" sites and other resources for discovering individuals
- 10 - 20 hours a month to work on 3 - 10 cases at a time

Child Prep Role

Our new "Extensive Team Recruitment" program, which provides a litany of services to local foster children, is in need of a Child Preparation volunteer. This role would include researching best practice methods for speaking with youth, making time to meet with children, and a big heart!

Qualifications:

- Experience in working with children (preferably professional experience, or working on a degree towards such)
- 10 - 20 hours a month dedicated to research and time spent with children
- Development of a "child preparation plan" that outlines best practice policies, methods, etc.

Internet Research:

Search the web for current contact information, more relative connections, family history, and more!

Calling and Engagement:

Call and speak one on one with relatives and lost loved ones in order to identify individuals who are committed to the youth and would make a good support network. Also speak with people who would know of more family connections.

Success Stories

Jason

Jason was seventeen years old when his case was referred to Family Finding. He had been in foster care for six years and had moved many times. Jason was considered an angry kid who found himself reacting violently when pestered by others. Jason's caseworker believed that he was a bright kid who just needed support and love around him. Jason was living in a group home, and had no connection with his biological family.

process, and one of the most vital steps is follow-up! By following up with case staff and family members, we ensure that family meeting plans are followed, and that relatives, connections, and other loved ones are able to adequately support the youth! Follow up for a case begins within 3 weeks after a first family meeting, and continues for up to a year.

Qualifications:

- Ability to keep detailed notes and adequately update them in our database
- Refined communication skills
- Ability to meet strict deadlines and do timely reports
- 2 - 5 hours a month working on 4 - 10 cases

Community Engagement Coordinator

One of the most important and accessible tools we have to help our organization help foster youth is right here in our community...our people! By reaching out to volunteer organizations, local schools, government members, and other influential groups we can educate the public about life for youth in foster care and how "Family Finding" has the potential to remove and keep children out of foster care, as well as create lifelong, loving relationships for foster youth.

Qualifications:

- Ability to research and present information in an effective manner
- Good public speaker
- Ability to reach out to and engage community groups
- Availability to present to community groups
- 5 - 10 hours a month creating presentations and bringing such to groups and organizations

The Family Finding volunteer mined Jason's files and found many relatives whom Jason had had no contact with for a very long time. Some relatives were experiencing personal problems when Jason was taken into foster care, and were unable to provide for him at that time. There were some relatives that Jason said he was not interested in speaking to, particularly his father. Jason was worried that some of his relatives were still engaging in inappropriate behavior. When the volunteer began calling relatives, she found that there were many people who loved Jason and were capable of being a part of a stable support system. Not only were there family members who case staff were unaware of, but many family members has also changed for the better, especially Jason's dad.

The family meeting involved both of Jason's grandmothers, his aunts, an uncle, and his father. The meeting was very emotional. Jason's father shared that he was distraught about Jason's young life before he was removed from his care. He recognized that he had changed - he was employed, in a committed relationship, and ready to be a father to his son. All of the family members present expressed that they loved Jason very much, and wanted to be there for him however they could be.

Jason's caseworker was pleased to see so many relatives who cared so deeply for Jason. He invited Jason's father to lunch the next day so that Jason could meet him. Jason, his dad, and Jason's caseworker dined together and Jason and his dad began a budding relationship.

Jason now visits with his father regularly. He also sees his half siblings and his aunt on a regular basis. He even went on a family trip with his aunt and cousins! Even better, Jason is no longer considered an

Family Unknowingly Adopts Distant Cousin

Steve and Janine Hamilton have always felt deeply connected to their adopted daughter, but that connection was felt even more deeply this year when the family discovered that she is, in fact, a blood relative.

The Hamiltons adopted Sarah, who recently married and took McBride as her last name, nine years ago when they lived in Kansas City.

Sarah, now 19, was born in Texas and was being raised in Kansas City before she went into the foster care system at the age of 8 with her siblings.

In the meantime, the Hamiltons had checked into adoption but weren't counting on anything happening because they were beginning a move to Rapid City. Instead, just a couple months before the move, they got a call about Sarah, an 11-year-old who needed a home. She joined them in August of 2003, and the family moved to South Dakota that October.

It was good timing, Janine said, because it gave Sarah a fresh start in a new home that also was new to the rest of the family. Steve and Janine had three biological children at home.

At that time, Steve said, "We had no clue," that their new daughter could be related to them. It wasn't until 1940 United States Census data was released that a relative started doing some research and discovered that Sarah is Steve's fourth cousin once removed. That means Sarah's brothers and sisters in the Hamilton family are her fifth cousins.

The news was unbelievable, Steve said.

"Years ago, we joked that we might be related," Steve said. "Everybody's been having fun with it. The whole family's kind of excited."

Sarah, who still keeps in touch with some of her biological siblings, was also surprised by the news.

"I thought it was very cool," she said. "I love history."

The chances, she added, of their paths crossing like they did are very small. "It all happened for a reason," she said.

Janine said Sarah faced many of the emotional challenges that kids in foster care face. Because she was older when she entered the system, it was difficult to leave one family and live with another.

"The kids always long for a connection," Steve said, and oftentimes that connection has to be made in the way of

"angry kid" and no longer reacts violently when he is upset. Jason has people in his life who love him, and will likely be there for him permanently.

support, love and time. That's how it was done with Sarah, and this is just icing on the cake, Steve said.

It is nice news to hear, Sarah said, but it doesn't really change the way she sees her parents.

"I've already grown to be close to them," she said. "I've always belonged to them."
